### Savoeun Orders New Action Plan For Airport Security

Deputy Prime Minister Neth Savoeun, who is also the Chairman of the National Civil Aviation Security Committee, has instructed the leaders of all relevant units and institutions to prepare a new action plan to ensure security and order at international airports. Savoeun made these remarks at the 2024 work results summary meeting of the National Civil Aviation Security Committee held on Monday. Savoeun added that the new action plan aims to ensure security and order for both national and international visitors at all international airports. He emphasised that all relevant parties must effectively implement this plan in managing Cambodian civil aviation security.

A teenager was charged on Friday (Mar 7) with "endangering" the safety of a commercial flight in Australia after trying to sneak on board with a shotgun and ammunition, police said. The 17-year-old was overpowered by passengers and pinned to the floor of the plane after trying to climb on board the Jetstar flight near Melbourne on Thursday afternoon, Victoria Police said. Police alleged he crept through a hole in the security fence surrounding Avalon airport, about 60km southwest of Melbourne city.

The Canadian Air Transport Security Authority (CATSA) is trialling a new customised screening line at Québec City Jean Lesage International Airport (YQB), the first airport in Canada to do so. The new line, known as screening line 6, offers the benefits of a CATSA Plus system, allowing up to three passengers to place their belongings in screening bins simultaneously.

## Colombian Police Catch a Man Smuggling Packets of Cocaine Under Toupee

Colombian police apprehended a 40-year-old man attempting to smuggle several bags of cocaine concealed beneath a meticulously attached toupee. Police said the suspect was detained at Cartagena's airport on Monday as he prepared to board a flight to Amsterdam. A scanner revealed the hidden cargo: 220 grams of cocaine packaged in small bags, strategically placed under what authorities described as a "narco wig."





## **Evacuation Declared at Tbilisi International Airport**

It is believed information was received about explosive devices at the airport, however, the Ministry of Internal Affairs has not yet issued a statement on this fact despite the topic of high public interest. The SITA 2024 Air Transport IT Insights report indicates that airlines and airports are raising their IT budgets, with an emphasis on enhancing cybersecurity, implementing biometric systems, and adopting eco-friendly technologies. The report anticipates a rise in overall IT expenditure, with airlines' spending expected to hit \$37bn and airports' expenditure by nearly \$9bn over the next two years. Cybersecurity emerges as a top priority, with 66% of airlines and 73% of airports identifying it as their primary concerns.

## **EU Lifts Interim Measures in Lufthansa Antitrust Investigation**

The European Commission has dropped previously announced interim measures against Lufthansa as part of an ongoing antitrust investigation, it said today. The Commission said last month that it would order the German carrier to reinstate charter airline Condor's access to Lufthansa's short-haul network to feed Condor's Frankfurt-New York route. The order related to an investigation of a joint venture between Lufthansa, United Airlines and Air Canada, which the EU executive believes could restrict competition for flights between Frankfurt and New York. The Commission had said Lufthansa should reinstate arrangements agreed in June 2024 that provided feeder traffic to Condor to and from Frankfurt, which had ceased to apply in December.





## Five Arrested for Forging Airport Entry Pass at Goa International Airport



In a major security breach at Goa International Airport, Dabolim, five individuals were arrested for allegedly forging Airport Entry Passes (AEP) and using them to gain unauthorized access to the restricted area of the airport terminal.
