Man Charged After Trespassing Onto Tarmac at Major Airport

A man who had been in the bushes next to a major Australian airport and made his way onto the tarmac has pleaded guilty to trespassing. The 33-year-old man from Perth was stopped by airline workers who spotted him on the Perth Airport tarmac about 9:30 pm on Tuesday. He managed to enter the airport from bushland and reach the tarmac before he was arrested by the Australian Federal Police. He appeared in the Perth Magistrates Court on Wednesday, where he pleaded guilty to trespassing on Commonwealth land. AFP detective acting inspector Aden Jama said it was dangerous for unauthorized people to be on the tarmac around aircraft, and such incidents also put workers at risk.

Gunnebo Entrance Control has completed a large-scale biometric security deployment at China's Chongqing Jiangbei International Airport, installing more than 150 intelligent At the heart of the deployment is Gunnebo's BoardSec system, which integrates facial recognition technology with visual behavior analysis. Using camera arrays and deep-learning algorithms, the system is capable of identifying more than 20 potentially risky behaviors, including tailgating, reversing, and the presence of unattended luggage. When suspicious activity is detected, the system automatically alerts airport security personnel for immediate intervention.





Moldovan Man Arrested at Paphos Airport on International Drug Warrant



Police arrested a 46-year-old Moldovan national at Paphos Airport on Thursday on an international arrest warrant related to drug offences. The man was detained upon arrival at the airport by authorities acting on a warrant issued by Moldovan officials in 2018. The arrest is part of ongoing international cooperation between Cyprus and Moldova in criminal matters.



Global travel is undergoing a transformative surge. In 2024, Dubai International Airport handled over 700 million passengers, while Abu Dhabi Airports reported a 28% year-on-year increase in passenger traffic. With passenger numbers expected to reach 8 billion annually by 2040, airports, airlines, and border control agencies face significant challenges, ranging from persistent staffing shortages and spatial constraints to a reliance on outdated technologies incapable of accommodating the burgeoning demand.

The passenger was remanded in judicial custody along with two members of the ground handling staff at Hyderabad's Rajiv Gandhi International Airport. The Directorate Of Revenue Intelligence (DRI) said it seized 3.5 kg of smuggled gold of foreign origin at Hyderabad's Rajiv Gandhi International Airport on Thursday. Officials of the DRI's Hyderabad zonal unit, acting on specific intelligence, intercepted an Indian passenger who had travelled from Dubai to Hyderabad via Muscat. He was intercepted near the aerobridge at the international passengers' arrival gate along with a ground handling staff member working at the airport, a DRI statement said.





Bomb Threat Rocks Thiruvananthapuram Airport Ahead of PM Visit



Security forces conducted an extensive combing operation at the Thiruvananthapuram International Airport following yet another bomb threat received on Tuesday evening. The threat, which emerged ahead of Prime Minister Narendra Modi's scheduled visit to the city, prompted heightened security measures at the airport. The e-mail reportedly claiming responsibility from "Hizbul Mujahideen", stated that bombs have been planted in a toilet and at the airport's exit point, set to detonate within 24 hours.

The Qilin ransomware group has taken credit for the cyberattack on Kuala Lumpur International Airport (KLIA) last month. The assertion from the group was made earlier this week, but the airport has not confirmed it. Reports stated that the disruption began on March 23, 2025, affecting flight information displays, check-in counters, and baggage handling. Staff were forced to post departure times on dry-erase boards manually. Moreover, airport officials reported they declined a \$10 million ransom demand but did not identify the attacker. The alleged ransomware group claims to have stolen 2 TB of data during the incident.





NAMA Flags Poor Synergy, Obsolete Equipment as Threats to Aviation Security

Nigerian Airspace Management Agency, NAMA, has identified challenges hindering the effectiveness of aviation security in Nigeria, saying they include lack of Synergy among security agencies, inadequate investment in security infrastructure and poor recruitment. NAMA, which said collaboration among security agencies was weak despite the shared responsibility for securing aviation infrastructure, added that motivation among aviation security personnel was poor.
