Man Held With Forged Travel Documents at Dhaka Airport

A man was detained on Monday at the domestic terminal of Hazrat Shahjalal International Airport for attempting to travel using forged documents, including a boarding pass, ticket, and passport. The individual, identified as Aman, was apprehended in the afternoon while intending to board a Biman Bangladesh Airlines flight bound for Cox's Bazar. "Airport authorities immediately handed him over to the airport magistrate for further legal action," HSIA Executive Director Group Captain SM Ragib Samad told BSS. "Airport security remains on high alert, and any attempt to breach aviation protocol with fraudulent means will be dealt with strictly," he added.

HK Customs Seizes HK\$6.9 Million Worth of Suspected Cannabis In Airport

Hong Kong Customs uncovered a drug trafficking incident involving baggage concealment at Hong Kong International Airport on 25th May. Authorities confiscated approximately 32 kilograms of suspected cannabis buds, valued at around HK\$6.9 million. A 23-year-old female passenger, arriving from Vancouver, Canada, was flagged during customs clearance. Customs officials discovered the stash of suspected cannabis buds concealed within her two check-in suitcases, leading to her immediate arrest. The individual in custody faces a charge of trafficking in a dangerous drug, with the case scheduled for hearing at the West Kowloon Magistrates' Court on 27th May.

A 51-year-old man who stole from a fellow passenger on a Scoot flight was jailed for 10 months on Wednesday (May 28). Zhang Kun, a Chinese national, earlier pleaded guilty to one charge of theft. The offence took place on flight TR465 from Kuala Lumpur to Singapore on Mar 16. Zhang was seated three rows behind the victim, whose backpack, containing a sling bag and a wallet, was in the overhead compartment. During the night flight, the victim and his companion left their seats to celebrate a birthday with their friends at the back of the plane.

A bomb threat on board a Ryanair plane has suspended all flights and closed a runway at Brussels Airport. The alert was sounded on a Ryanair flight that arrived at Brussels South Charleroi Airport from Porto shortly before 11am today. A spokesperson for Ryanair told Metro the bomb threat was a hoax. They added that all passengers have been disembarked from the flight. No flights are departing or arriving the international airport but the terminal has not been evacuated. A Ryanair spokesperson told Metro: 'Ryanair was informed of a security threat on flight FR6313 from Faro to Brussels Charleroi today, 13th May.

Jail for Man Who Had to be Restrained in 'Air Rage' Case

A man was jailed for five weeks on Wednesday (May 14) for an episode of "air rage" during which he had to be physically restrained on a Scoot flight. Kolathu James Leo, 42, pleaded guilty to one count of boarding a plane in such a state of intoxication that he jeopardised the good order and discipline required on the flight. The offence under the Air Navigation Act carries a jail term of up to a year, a fine of up to S\$20,000 (US\$15,370) or both penalties. He faced two other charges of criminal force and harassment — by grabbing a crew member's wrist and threatening to kill him — that were considered for sentencing.





Bomb Scare Grounds AirAsia Flight at Phuket Airport



A Thai passenger was detained after allegedly claiming an explosive device was on board, prompting a full emergency response. Phuket International Airport activated its emergency protocols this afternoon following a bomb threat made aboard a domestic AirAsia flight. Airports of Thailand (AOT) confirmed that the situation was swiftly brought under control, with no suspicious items found. At approximately 3:17 PM local time today (May 23), Phuket Airport's Air Traffic Control (ATC) was alerted by the pilot of AirAsia flight FD3092, an Airbus A321 bound for Don Mueang (DMK) from Phuket (HKT). The pilot had been informed by cab.

A woman found with a bag of cash and £800 of JD Sports vouchers is believed to have been smuggling suspected drug money. Liverpool woman Danielle Shields flew in to Jersey on February 7 this year when she was stopped by customs officers. The 43-year-old, who had £20 and her bank card, told officers she was staying at the luxurious Royal Yacht hotel. But the following day, travelling outbound to Liverpool, Shields was stopped again, with officers this time finding a huge haul of cash in her baggage. As well as £2,336 in cash, she also had JD Sports gift vouchers to the value of £800, receipts for clothing and a Jersey Post receipt for an outbound package. She also admitted to internally concealing a further £1,360 and was also found wearing a new Tag Heuer watch. Officers later retrieved the outbound package that Shields had the receipt for, which was found to contain an empty Tag Heuer box and a receipt for £2,100. During her police interview, she admitted to attempting to export the cash that she suspected to be the proceeds of crime, possibly from the sale of drugs.
